## “Buy Local” Promotion – 24 October 2016 to 25 November 2016

### TERMS AND CONDITIONS

- 1 The promotion is organised by the Northern Illawarra Chamber of Commerce Inc (“NICC”), ABN 48 736 796 032, P.O. Box 396, Helensburgh, NSW, 2508. Phone 0242941008.
- 2 Information on how to enter and prizes form part of these Terms and Conditions.
- 3 Entry is only open to Australian residents aged 18 or older as at 24 October 2016.
- 4 To enter, you must spend \$20 or more at any NICC member business between 24 October 2016 and 25 November 2016 and complete the entry form available from the business. Only one entry is permitted regardless of amount spent at time of the visit to the NICC member business. Multiple entries from the one NICC member business are permitted if more than \$20 is spent each visit.
- 5 The winner will be drawn at the NICC meeting on Friday 2 December 2016 at 8.00pm.
- 6 Where an NICC member business does not charge for their service, then they can use their discretion to enter their customers in the draw with their consent during the competition period from 24 October 2016 to 25 November 2016.

- 8 The prizes for the promotion are (1) \$1000 (comprising 50 \$20 vouchers); (2) \$500 (comprising 25 \$20 vouchers) and (3) \$300 (comprising 15 \$20 vouchers) to spend at one or more NICC member businesses. The prize must be taken by 31 March 2017.
- 9 The prize consists of one (1) draw per prize with the first valid entry to win. The judge’s decision is final and no correspondence will be entered into.
